By accessing the Website, you agree to be bound by this Privacy Policy. Please read this document carefully and visit this section frequently as this Privacy Policy may be updated and or modified at any time without prior notice. ### **PERSONAL INFORMATION**

We base our treatment of your Personal Information on the following grounds:

- Fulfil our legal or regulatory responsibilities;
- Protect a vital interest of the Company.

#### **SCOPE OF TREATMENT**

We will only process your Personal Information for the purposes detailed above. We will keep your Personal Information for as long as it is required in order to fulfil the relevant purposes described herein and in the Terms of Services. We will destroy or permanently de-identify the Personal Information we hold when it is no longer required.

#### **LOG DATA**

When you visit the Website, we collect Log Data, such as your IP address, browser version, pages of our Service that you visit, the time and date of your visit, the time spent on those pages, and other statistics. We may use third-party services to collect, monitor and analyze Log Data. However we are not responsible

and/or liable for said third parties' use of your Information which is not governed by this Privacy Policy. You can enable or disable location services at any time through your device settings.
